Ed O'Bannon Takes on the N.C.A.A. The New York Times

This e-single, a compilation of articles from The New York Times, tells the story of Ed O'Bannon, a former U.C.L.A. basketball star who in 2009 filed a lawsuit against the N.C.A.A. O'Bannon had seen himself in a video game years after graduation and wondered why others were making money off him.

In 2014, in a landmark case for college sports, a federal judge ruled that the N.C.A.A.'s longstanding rules barring payments to college athletes were in violation of antitrust laws. Judge Claudia Wilken of United States District Court in Oakland, Calif., issued an injunction against rules prohibiting athletes from earning money from the use of their names and images in video games and television broadcasts.

The decision would allow universities to offer football players in the top 10 conferences and all Division I men's basketball players trust funds that can be tapped after graduation. It did not mandate that players be paid.

But in September 2015 an appeals court ruled that the N.C.A.A. may restrict colleges from compensating athletes beyond the cost of attendance, an apparent victory for the college sports establishment as it fights efforts to expand athletes' rights. Lawyers for the athletes have asked the United States Court of Appeals for the Ninth Circuit to review its decision.

Other lawsuits that threaten the status quo are moving forward, suggesting that change may lie ahead for how the N.C.A.A. operates.
